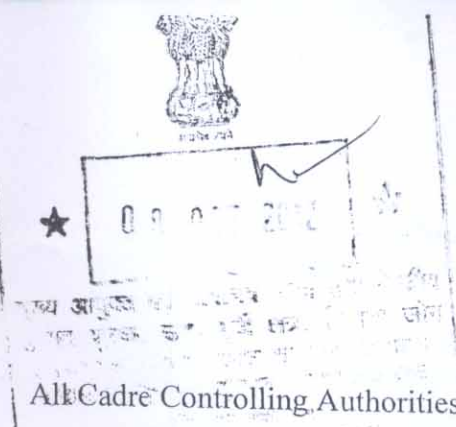

I am directed to refer to this department's letter of even number dated 08.04.2011 (copy enclosed) vide which Board's decision that the exercise of carrying out corrections in the AISLs for the period from 01.01.1986 to 31.12.1992 and 01.01.193 to 31.12.1997 should no longer be kept open-ended, was conveyed. However, representations from individual officers on the subject above are still being received, making it difficult to complete the job.

2. All the Cadre Controlling Authorities are, therefore, requested to send such representations received from the individual officers alongwith the specific recommendations of the CCAs, supported by the authenticated documentary evidence, to the Board latest by **31.10.2012**. It may be noted that this is last opportunity and **proposals received after the above cut-off date will not be entertained**. It may please be noted that cases that form part of the consolidated proposal being submitted by the CCAs will only be considered for carrying out corrections in the above AISLs and **no isolated case** which is not included in the consolidated proposal, will henceforth be considered. In case no such case exists, a '**nil**' report may be sent to the Board positively by **31.10.2012**.

Subject:-Corrections in the All India Seniority Lists of Superintendents of Central Excise for the period from 01.01.1986 to 31.12.1992 and 01.01.1993 to 31.12.1997

Sir,

It has been observed that a number of representations are being received from various Cadre Controlling Authorities under CBEC individual officers with/without the specific recommendations/confirmation of information of the Cadre Controlling Authorities for carrying out corrections in the All India Seniority Lists (AISLs) of Superintendents of Central Excise for the period from 01.01.1986 to 31.12.1992 and 01.01.1993 to 31.12.1997.

2. The matter has been examined in the Board (CBEC) and it has been decided that the exercise of carrying out corrections in the AISLs for the above mentioned period in respect of personal particulars should no longer be kept open-ended. However, with a view to pre-empt possible litigations, it has been decided to invite representations from the concerned officers, as a last opportunity, for making corrections in the above said AISLs through the concerned CCAs.


3. All the Cadre Controlling Authorities are, therefore, requested to bring the above decision of the Board to the notice of all the Superintendents under their administrative control included in the AISLs for the period from 01.01.1986 to 31.12.1992 and 01.01.1993 to 31.12.1997 and forward such representations received from the individual officers alongwith the specific recommendations of the Cadre Controlling Authorities, supported by documentary evidence to the Board latest by **30.04.2011**. **Proposals received after the above cut-off date will not be entertained.**

4. All the Cadre Controlling Authorities (CCAs) under CBEC may also send copies of proposals already referred to the Board but are still pending for carrying out corrections, alongwith the proposal being submitted to the Board in pursuance of the decision mentioned at Para 3 above. It may please be noted that cases that form part of the consolidated proposal being submitted by the CCAs incorporating the representations from the individual officers in response of the last opportunity being given and the cases pending with the CCAs/Board will only be considered for carrying out corrections in the AISLs and no isolated cases which are not included in the consolidated proposal will hence forth be considered.
