Subject: - Calling of options/willingness for posting of Superintendent and Inspector on local transfer/loan basis in the Zonal Unit of DGGSTI, Guwahati – reg.

*5 posts of Supdt. and 2 posts of Insp. in Guwahati ZU and 1 post of Insp. in Shillong RU are already under consideration. Hence, present actual vacancies in these ZU/RU are 3 posts of Supdt. and 14 posts of Insp. Guwahati ZU and 3 posts of Supdt. and 5 posts of Insp. in Shillong RU.

2. These posts will be filled up on local transfer/loan basis from amongst the officers of the similar rank working in the formations of Customs and GST of this Zone.

3. Such officers selected for a posting in the ZU and RUs of DGGSTI, Guwahati would normally be appointed for a period of 2 years initially.

4. The salary of such officers selected will be drawn from the budgetary head of CCO. However, there will be no deputation allowance for such posting.
