Subject:- Convening a meeting to resolve the issue of seniority for promotion of Inspector to the grade of Superintendent- reg.

Promotion from the grade of Inspector to Superintendent in this Zone has not been held for a long time. In view of the various disputes among the direct recruits as well as promotee officers regarding the seniority list of the Inspectors, some of the officers have obtained an order from CAT, Guwahati vide order dated 08/11/2017.

2. Department has filed a Writ Petition in Hon'ble Guwahati High Court against the CAT Order vide Writ Petition No. WP(C)3118/2018 dated 07/05/2018 which is pending . Several of the officers in the grade of Inspector and the associations have been representing to me to resolve the issue of seniority list and to conduct DPC for promotion from grade of Inspector to Superintendent.

3. To discuss the issue and resolve the same keeping in view the various judicial decisions as well as Board Instructions, it has been decided to hold a meeting of all the stake holders on 16/05/2019 at 11 A.M in the Conference Hall, 5th Floor, Kedar Road, GST Bhawan, Guwahati-781001.

Das, Assistant Commissioner, Wazim Mustafa, Assistant Commissioner & U.K. Saha, A.O who dealt with this issue earlier shall present in the meeting with all the inputs relating to this subject. They may be informed accordingly.

5. You may inform the Inspector's Association (Both direct recruits and promotees in the jurisdiction of your Commissionerate) as well as any other officer having stake in the issue, to attend the meeting

6. The associations/individual officers who are attending the meeting may be advised to bring a Note on this issue and to suggest solution to resolve the same and go ahead with the DPC meeting.
