Establishment Order No. 140/2012

Date: Shillong, the 24th September, 2012

Sub: Clarification on 6th CPC replacement pay to the pre-revised scale of pay of ₹8000-275-13500 granted on account of financial up-gradation under the Assured Career Progression Scheme.

In terms of the CBEC's letter F. No. A-23011/29/2010-Ad.II A dated 20.05.2011, those **Superintendents** who had been granted **pre-revised scale of ₹ 8000-275-13500** as financial up-gradation under the **ACP Scheme** on or before **31.08.2008** shall be placed in **PB-3 ₹ 15600-39100 with GP ₹ 5400**. Hence, such Superintendents, on completion of 4 years in the grade, **would not be eligible** for non-functional scale with GP ₹ 5400 in PB-2 with the benefit of one increment @ 3% ordered vide CBEC's letter F. No. A.26017/98/2008-Ad.II (A) dated 23.12.2009. An order to this effect was also issued by this office vide Establishment Order No. 31/2011 dated 25.10.2011, with the direction to re-fix the pay of such Superintendents. However, on scrutiny of the Service Books of Superintendents who have completed 30 years of regular service in the year 2012, it has been noticed that no such re-fixation of pay has been done. Consequently, **such Superintendents cannot be considered for 3rd financial up-gradation under the MACP Scheme as financial up-gradations granted in the Grade Pay of ₹ 5400 in PB-2 and PB-3 would be counted as separate up-gradations and would be offset against the Scheme.**

In view of the above, all the DDOs are hereby directed to immediately carry out re-fixation of the pay of the said Superintendents, and furnish compliance reports to this office as early as possible. List of such Superintendents, *who would otherwise be eligible for 3rd financial up-gradation under the MACP Scheme*, is enclosed herewith for ready reference. All other similar cases shall also be dealt with accordingly.

This issues with the approval of the Chief Commissioner.
