## CIRCULAR

Dated, Shillong, the 4<sup>th</sup> April, 2018.

**Subject:- Preparation of panel for Air Customs Officer (ACO) for posting at Chennai Anna International Airport against 25% quota – reg.**

The Chief Commissioner, Goods and Services Tax, Shillong is pleased to draw a panel for filling up 1 (one) post of Air Customs Officer (ACO) from willing and eligible Inspector for posting at Chennai Anna International Airport against 25% quota on deputation basis subject to terms and conditions prescribed by the concerned Commissionerate. The terms and conditions are enclosed for ready reference of interested officers.

It is proposed to fill up the post by drawing a panel of suitable officers on deputation basis. While exercising the option, it may please be made clear to the willing officer that option once exercised would be final and in the event of selection, he/ she will not be allowed to withdraw the same. The officer selected for posting in the Airport would normally be appointed for a period of 2 years. However, an officer at the Airport can be reverted before completion of 2 years without assigning any reason. Selected candidates will have to make their own arrangements for residential accommodation.

While forwarding the name of officers, the following information should also be sent:

- (a) Bio-data, which must indicate the date of birth and the date of appointment to the present cadre of the officer concerned.
- (b) History of posting.
- (c) Anti-Smuggling experience.
- (d) Willingness of the officer.
- (e) Date of Superannuation.
- (f) Latest Seniority List No.

The name of willing officers along with the above information may please be forwarded to this office latest by 23.04.2018.

The terms and conditions for selection and posting at Chennai Anna International Airport, Chennai as Air Customs Officer are as under:-

1. The officer posted at the Airport will be eligible to draw pay and allowances at the same rates as admissible to them from time to time.
2. He/ She shall be considered to be on deputation at the Airport but no deputation allowance is admissible to them.
3. Normally the period of deputation at the Airport is two years. However, an officer at the Airport can be reverted before completion of 2 years without assigning any reason.
4. The officer posted at the Airport will have to make his/her own arrangements for residential accommodation.
5. In the event of their promotion to higher grade, the officer will be liable to be reverted to their parent Commissionerate or posted anywhere as may be ordered by the Competent Authority in this regard.
6. The officer will also be entitled to draw uniform and diet allowance as admissible under the rules.

The following officers are not eligible for consideration for posting at Chennai Anna International Airport, Chennai.

- a. Officers transferred out of Airport/ Sensitive places on administrative grounds.
- b. Officers with less than 2 years cooling off period on their return from Airport/ DGRI/ DGAE/ NCB/ ED(FERA) SEIB in terms of Ministry's instructions issued under F.No.A-35017/28/92-Ad.III-B dated 30.06.1994.
- c. Officers with vigilance/ non-vigilance cases pending against them.
- d. Officers against whom penalty is operative.
- e. Officers due for retirement upto 30.04.2020.
- f. Officers with less than 5 (Five) years service as Inspector of Goods and Services Tax as on 31.01.2018 i.e. who joined as Inspectors on or after 31.01.2013.
