In view of the above, all concerned authorities are advised not to forward any representation for Inter Commissionerate Transfer (ICT) from the Inspectors working under their jurisdiction to this office until any amendment in the RR is made or alternative fresh instructions for Inter Commissionerate Transfer (ICT) is received from the Ministry/Board.
