

**TERMS AND CONDITIONS FOR DISPOSAL OF VEHICLE AGAINST
TENDER NOTICE, No.10/AUC/DISP/ACG/2015-16 Dated 20.08.15**

Interested Parties may submit their highest price for the vehicle in a sealed cover latest by 12.00PM on or before 27.08.2015. The inner cover containing quotations and other relevant documents alongwith Demand Draft towards FMD should be sealed properly. The cover should be put in another Outer Cover and may be dropped in the "Tender Box" which is kept in the door yard of the Disposal Unit, 1st Floor, Office of the Assistant Commissioner of Custom, Custom House, Nilamanj Phukan Path, Christian Basti, Guwahati-781005. Both the inner and the outer covers should be *superscribed* in Bold Capital letters "QUOTATION FOR DISPOSAL OF CONFISCATED VEHICLE".

2. The disposal of vehicle shall be strictly on "AS IS WHERE IS BASIS" and no Guarantee or Certificate of its worthiness or quality will be given by this Department. The condition of the vehicle can be inspected physically between 10.30AM to 3.00PM on any working day between 21.08.2015 to 26.08.2015 at the parking lot of Inland Container Depot, Amingaon, North Guwahati.

3. The quotation should be accompanied by earnest money for Rs 1,00,000 (Rupees One Lakh) only. The earnest money can be deposited by Bank Draft in favour of the Assistant Commissioner, Customs Division, Guwahati-5. The bank draft should be attached with the quotation letter failing which the quotation shall not be considered at all. If the highest tenderer/successful tenderer accepted by the competent authority in this Department fails to deposit the sale price within the prescribed time limit, his earnest money will be forfeited. In case the offer is withdrawn by any tenderer, the earnest money deposited by him shall be forfeited.

4. EMD amount is payable by means of DD in favour of the Assistant Commissioner, Customs Division, Guwahati-5. **(Payment by Cheque/Cash shall not be accepted).** Offers received without EMD amount shall not be considered at all by this Department.

5. The successful bidder will be required to deposit the total bid amount by means of TR-6 Challan under **A/C No. 10821901973 under "Head of Account No 00370029" (Sale Proceeds) and deposit the amount in SBI, Panbazar/Dispur Branch of Guwahati within 3(Three) working days of acceptance of the bid.**

6. EMD of the successful bidder will be released only after realization of Sale proceed amount. Earnest money Deposit of the bidders who fail to honour the bid in prescribed time limit shall stand forfeited. No representation in this regard shall be entertained by this Department. EMD amount will not be adjusted in the Sale Amount accepted by the Assistant Commissioner, Customs Division, Guwahati. EMD of successful bidder(s) shall be released only after successful completion of the sale process.

7. The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (Ration Card, Voters Identity Card, Driving License, etc.)
8. The sold vehicle will be removed by the successful bidder within 48 hours of depositing the money at their own expenses. No assistance/transportation will be provided by Customs, Guwahati. Permission to take out the disposed vehicle from parking lot of Inland Container Depot, Amingaon, Guwahati-31 will not be allowed on holidays, Saturdays and Sundays etc.
9. The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his/her name at his/her own cost expeditiously. This office will not be responsible for any lapse on his part in this regard.
10. EMD of the persons rescinding their offer, withdrawing or abrogating after submitting the bid shall stand forfeited. Decision of the Assistant Commissioner, Customs Division, Guwahati shall be final in this regard.
11. The Assistant Commissioner, Customs Division, Guwahati reserves the right to reject all or any tender in whole or part without assigning any reasons thereof.
12. EMD of unsuccessful tenderer shall be returned within 7(seven) working days after award of contract to successful party.
13. The bidder is to require to reveal his/her full name/name of the authorized signatory of the firm, name of father, full postal address, telephone number & mobile number.
14. Disputes, if any, shall be subject to jurisdiction in the Court of Kamrup(Metro) only.
15. If the highest quoting bidder fails to honour the bid, the award of the bid will be cancelled and his/her EMD forfeited. In such an event, an opportunity shall be given to the next highest quoting eligible tenderer (H-2 quoting party) to complete the bid provided it is prepared to accept the prices offered by the H-1 party. In case of any dispute, decision of the Assistant Commissioner, Customs Division, Guwahati shall be final.
16. Tendering form should be **signed in blue color pen** by the authorized signatory only. Photocopy or unsigned quotations or quotations not signed by authorized signatory shall be rejected.
17. Tendering person shall alone be responsible for furnishing any false or wrong information and the consequences or loss thereof.
