**Subject**: Posting of office bearers at the Headquarters of the Association regarding.

You are aware that the office of the Chief Commissioner, Guwahati Zone has been shifted from Shillong to Guwahati during July, 2019. Subsequent to the shifting, the Superintendents' Association in this Zone have submitted a letter to this office indicating their decision to shift the principal place of work of their Zonal Association to Guwahati.

- 2. It is seen from several other Zones as well as in the case of Superintendents' Association of this Zone, the Zonal Association is located at the Zonal Headquarters only. The administration is neither suggesting nor advising any Association to shift their Association to any place. It is for the Association to decide as to where the principal place of work of the Association in the Zone should be located. The administration desires to know the place at which they would like to continue (Shillong or shift to Guwahati) in the context of M.H.A,O.M No. 26/3/69-EStt.(B) dated 8th April, 1969 which reads as follows:
  - "4.(i) Transfer of the Union Executive to the Headquarters:- The Chief Executive of the Union is defined in the Constitution of the Union/Association, etc., or the General secretary or where the Chief Executive has not been specifically defined, the General Secretary may be brought on transfer to the Headquarters of the

administrative head as far as possible. If the transfer to the Headquarters involves exemption from field duty, such transfer facility should be restricted to Chief Executive/General Secretary and one other executive member of each of the recognized association. However, when specific guidelines are available in any particular department in the regard, those instructions would apply.

It was further clarified later that only Chief Executive or General Secretary will be retained at Hqrs. or brought to the Hqrs. on demand of the Association.

3. The above O.M would be followed on receipt of your reply regarding the location of your Zonal Association Headquarters. If no reply is received by 4.11.2019, it would be presumed that your Association Headquarters is at the same place as the Zonal Hqrs. and the matter will be dealt with accordingly.
