# Respected Sir,

Please refer to the CCO's letter C.No. I(22)5/ET/CCO/SH/2014 dated 11.10.2019 on the subject cited above wherein it was informed that your goodself will hold a meeting with all elected representatives from all recognized Zonal Associations in the Conference Hall of GST Bhawan, Guwahati on 15.10.2019.

In this connection, I, the undersigned, on behalf of this Association would like to place humble submission of the following points and views for your kind information, consideration and necessary action, please:

That Sir, it may be mentioned here that the executive members of this Inspectors' Association had an emergent meeting on 14.10.2019 to discuss on the subject matter as cited above. After threadbare discussions on the above agenda-point in the house by the members present, the house is of the view and also fully aware of the facts that many times the representatives of this Association had personally met the Chief Commissioner(s) (present as well as past) and also had submitted many representations regarding DPC, ICT matters etc. and sadly to which so far no positive outcomes / results or action can be seen or have been met from the other ends. Therefore, the house is of the opinion that it is of no point to attend the proposed meeting as of now when all our representations and demands have been still lying at the other ends without any desired positive results.

That Sir, regarding the litigation on draft Seniority list of Inspectors: it is now a known fact that the Hon'ble Gauhati High Court vide its Order dated 05.09.2019 has remanded back the matter to Gauhati CAT for denovo hearing. As such, this Inspectors' Association is of the opinion that the final decision for conduction of DPC rests with the Administration (CCA) for now. It may be also mentioned here that DPC has always been conducted timely in all other zones of CBIC irrespective of numbers of litigation/ Court cases going on. Moreover, DPC can always be held subject to the outcome of any Court case. And since there is no stay order on holding of DPC from any Court, the Administration is therefore, earnestly requested to hold the DPC immediately. It is disheartening to know the fact that CBIC Inspectors of this Zone have earned unique position for the most stagnated Zone across the country (now Inspectors rendering 18/19 years of service still waiting desperately for promotion to the grade of Superintendent in spite of available vacancies.
