Sub: Transfer of Superintendents.

Sir.

Kindly refer to the transfer order Dt. 14.08.19 of the Superintendents in the Guwahati Zone under your kind control.

- 2. It is to submit with due regards that gross injustice has been done in the cases like Sh. Utpal Das perhaps due to the oversight by the concerned section/authority. As per the Transfer Policy, the period for posting in one go at 'A' category station is six years but Sh. Das has been displaced only after five years instead of six. Even otherwise, his case is to be considered on compassionate grounds on account of serious condition of his mother.
- 3. The condition of his old & ailing mother is very serious. She can't even sit from bed herself. Sh. Das is the only person to look after his mother as he has no family. His retention at Guwahati is very much required to save his mother's life. His Mother is suffering from Parkinson's disease. She is under treatment in Guwahati itself.
- 4. As far as the health condition of Sh. Das is concerned, he is also a patient of depression and neuro-psychiatry and is under treatment in Guwahati itself. In addition, he is also suffering from jaundice. He was also hospitalised inemergency due to depression, panic attack and restlessnesson 15.10.19.
- 5. Under the prevailing circumstances as mentioned above, he is not in the position to go to Shillong Zone. It may be fatal for his mother as well as him.
- 6. In view of above, it is requested to kindly consider all compassionate cases like him sympathetically and retain them (including him) at Guwahati/requested place itself.
