**Subject:** Posting of office bearers at the Headquarters of the Association - reg **Madam**,

Please refer to your letter dated 31.10.2019 on the subject cited above.

In this connection, I, the undersigned, on behalf of this Association would like to place the following few lines for your information and necessary action, please.

That Madam, vide the above letter dated 31.10.2019 you have mentioned that the administration is neither suggesting nor advising any Association to shift their Association to any place and that it is for the Association to decide as to where the principal place of work of the Association in the Zone should be located.

Indeed, it is very true and it has been rightly pointed out that <u>it is for the Association only</u> to decide as to where the principal place of work of the Association in the <u>Zone should be located</u>.

Moreover, as per the MHA's O.M. dated 08.04.1969 it has clearly clarified that only <u>Chief Executive or General Secretary</u> will be <u>retained at Hqrs</u> or <u>brought to the Hqrs</u> on demand of the Association.

As such, this Inspectors' Association vide its resolution adopted during its emergent executive body meeting held at Shillong on 04.11.2019 has unanimously resolved and decided that as for the time being i.e. during the present tenure (from 2018-2020) of this current / incumbent office bearers the <u>location of the Zonal Association Headquarters</u> i.e. the principal place of work of this Inspectors' Association <u>should still be at Shillong</u>.

The Association has also resolved that this important issue of deciding location of the Zonal Association Headquarters would be taken up on priority basis and decided later positively at the time of the next General Election and GBM of the Association for election of new office bearers.

In view of the above, as of now it is our earnest request / demand that let all the current / incumbent office bearers of this Inspectors' Association still be posted at his or her current place of posting i.e. at Shillong during this present tenure (from 2018-2020) and as for Smti Ruma Medhi, Joint Secretary who is currently posted at Guwahati may also still continue to be posted at her current posting i.e. at Guwahati.
