Minutes of meeting with various staff associations held on 18.12.2020 at Shillong

Following staff associations and individual staff members interacted with Chief Commissioner, GST & Customs Guwahati zone in the conference hall of the Customs House at Secretariat Road, Shillong in the presence of Commissionerate CGST, Shillong.

- 2. The memoranda were received from Associations at Sl. No. 1, 2, 3 & 6 during and after the meeting raising various issues.
- 3. Chief Commissioner assured that proposed transfers of Superintendents and Inspectors within the zone will take place as per present policy and with minimum dislocation due to Covid-19 scenario. He also directed association to submit their stand on changes required on the present transfer policy for future implementation.
- 4. He directed CGST Commissionerate Shillong to look into grievances related to space shortage in Crescens Building in view of norms laid down by DG (HRD).
- 5. Various associations raised the issue of hardship faced by retiring/ retired officers/ staff. Chief Commissioner assured associations to look into delay in processing of retirement benefits so that the hardship of the retiring officers can be minimized.
- 6. Associations pointed out that the TA/ TTA bills are not processed in time and there is a delay. He assured associations that he will look into delay in disbursement of travel allowances/ TTA.
- 7. Chief Commissioner requested casual workers and daily wages workers to give it in writing their exact grievances. Accordingly they submitted their representations dated 21.12.2020. (AO, CCO for action)
- 8. He also requested Ministerial Association to specify clearly their association problem by having a meeting with him in his Guwahati office. Accordingly Shri Prashant Yadav, Tax Assistant, Accounts branch submitted representation dated 17.12.2020 to Commissioner CGST Shillong for further submission to Chief Commissioner, Guwahati Zone.
- 9. Chief Commissioner assured inspectors association that henceforth DPC will be conducted in the early part of the year provided matter of holding DPC is free from legal dispute. He also assured that he will look into issues related 3rd financial upgradation as well as ground of NFU. On the matter of omission of few eligible inspectors from the promotion during recently conducted DPC he informed concerned inspectors association that the legal opinion on the applicability of the CAT order is being sought of by his office and on receiving the legal opinion further action will be decided.
- 10. Meeting with various associations and individuals ended with vote of thanks for the attention bestowed by hon'ble Chief Commissioner.
