Subject:- Option for posting in NACIN, ZTI, Shillong on Deputation basis-reg.

The Chief Commissioner, Goods and Services Tax & Customs, Guwahati Zone is pleased to draw a panel for filling up the post of Superintendent on deputation basis from willing and eligible officers for posting in the National Academy of Customs, Indirect Tax & Narcotics(NACIN), ZTI, Shillong as shown in the table below:

It is proposed to fill up the post by drawing a panel of suitable officers on deputation basis. The terms and conditions are as below for ready reference of interested officers:-

- Officer selected for posting in NACIN ZTI Shillong on deputation would normally be appointed for a period of 3 (Three years) extendable upto 5 (Five) years and will be eligible for prescribed deputation allowance as per extant instructions.
- 2. The officer once selected will not be allowed to withdraw their option and they are expected to serve NACIN ZC Shillong till the expiry of the period.
- 3. While forwarding the name of officers, the following information should also be sent:-
 - (i) Date of birth
 - (ii) Educational Qualifications
 - (iii)Present post held and place of working
 - (iv) Date from which present post held and scale of pay.
- In case while working in the directorate, if the conduct and work of the officer is not found satisfactory, the officer shall be reverted to the Commissionerate prematurely without assigning any reasons.
