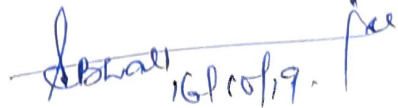
Enclosed please find herewith the History of Posting of Superintendents posted to CCO, Guwahati as submitted by them for your kind information and necessary action.

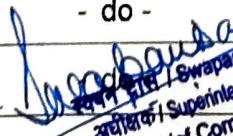
