SSC CGLE 2015 & CGLE 2016 Batch, though joined after her, were Recruitment of Vacancy Year 2014-15 & 2015-16, thereby placed above her as her vacancy year was 2016-17.

However, the sequence of seniority inbetween the Compassionate batch of 2016-17 is rectified and her position in the Draft List (below Sh. Tellang Seiminthang) is changed by placing her just below Sh. Chamgai Gangmei D to the extent of applicable OMs while drawing the final list.
