PROMOTION

Smt. Tracy T. The officer shall not be entitled to get the benefit of pay fixation as she has already been granted financial up-gradation under the ACP Scheme involving Grade Pay of ₹ 4800/- vide Establishment Order No. 52/2007 dated 02.07.2007.

In the event of refusal of promotion, she would be debarred from promotion for a period of one year.
