No. A-32012/4/2000-Ad.II-B (Vol. IV) dated 25.04.2007 and the same has been kept in abeyance as per Ministry's letter dated 08.10.2007.

The above officers at Sl.Nos. 1-8, 10, 11, 17, 19, 20, 23-29, 31, 32, 41, 43, 45, 47-49 & 51-53 are not entitled to get the benefit of pay fixation as they have already been granted financial up-gradation under the ACP / MACP Scheme involving Grade Pay of ₹ 4800 / ₹ 5400.

The seniority of the officers in the grade of Superintendent shall be in the order shown above.

In the event of refusal of promotion, they would be debarred from promotion for a period of one year
