The above mentioned officers are not entitled to get the benefit of pay fixation as they have already been granted financial upgradation involving GP of `4,800/- and `5,400/- under ACP/MACP Scheme vide this office Establishment Order Nos. 02/2005 dated 04.01.2005, 101/2010 dated 16.06.2010 and 142/2015 dated 29.07.2015 respectively.

The seniority of the above mentioned officers in the grade of Superintendent shall be in the order shown above.

In the event of refusal of promotion, they would be debarred from promotion for a period of one year.
