No. A-32012/4/2000-Ad.II-B (Vol. IV) dated 25.04.2007 and the same has been kept in abeyance as per Ministry's letter dated 08.10.2007.

The above mentioned officers appearing at Sl. No. 1, 3 & 4 are not entitled to get the benefit of pay fixation as they have already been granted financial upgradation involving GP of ₹4,800/- under ACP/MACP Scheme vide this office Establishment Order Nos. 38/2008 dated 11.11.2008 and 190/2015 dated 26.11.2015 respectively.

The officer at Sl. No. 2 is hereby asked to exercise option for pay fixation under FR 22 (I) (a) (1), within one month from the date of promotion. Option once exercised shall be final.

In the event of refusal of promotion, they would be debarred from promotion for a period of one year.
