However, officers who have already got financial upgradation under the ACP/MACP Scheme involving Grade Pay of ₹ 1,900/- or above are not entitled to get the benefit of pay fixation. Hence, no option is required for them.

In the event of refusal of promotion they would be debarred from promotion for a period of one year.
