However, this promotion is subject to the outcome of the Review DPC to be conducted as per CAT, Chandigarh and Patna Benches judgments dated 05.05.2006 & 06.02.2007, communicated vide Ministry's letter F. No. A-32012/4/2000-Ad.II-B (Vol. IV) dated 25.04.2007 and the same has been kept in abeyance as per Ministry's letter dated 08.10.2007.

The above mentioned officers appearing at Sl. No. 1, 3, 6 & 7 are not entitled to get the benefit of pay fixation as they have already been granted financial up-gradation involving GP of ₹4,800/- under the MACP Scheme, other officers are hereby asked to exercise option for pay fixation under FR 22 (I) (a) (1), within one month from the date of promotion. Option once exercised shall be final.

The seniority of the above mentioned officers in the grade of Superintendent shall be in the order shown above.

All the above officers should join the post on promotion within 15 (Fifteen) days from the date of issue of this order, failing which, it will be treated that they have not accepted the promotion ab-initio and as a consequence they would be debarred from promotion for a period of one year.
