The promotion is being made purely on ad-hoc basis in pursuance to Hon'ble CAT, Guwahati's order dated 26.11.2019 in M.A./40/167/2019 on O.A./40/215/2016 in the matter of Jayanta Dey vs. Central Excise and Customs. The above ad-hoc promotion will not confer any right for regular promotions and the promotion shall be until further orders. This office reserves the right to cancel the ad-hoc promotion and revert the officer at any time to the post from which the officer was promoted.

3. The above promotion to the grade of Superintendent is purely on ad-hoc basis from the date of joining in the grade and this does not confer on them any right to claim for regular promotion and any other Service Benefit or Seniority. Their promotion is also subject to the relevant conditions prescribed for ad-hoc appointment as stated in DOP&T's OM. No. 28036/8/87-Estt(D) dated 30-03-1988 and the Govt. Of India DOPT .A.R. O.M. No. 36011/14/83-Estt(SCT), dated 30-04-1983 and also relevant instructions issued by the Board in this regard from time to time.

4. The above promotions are subject to the final outcome of the O.A. No.40/215/2016 filed by Sh. Jayanta Dey & Ors. Which is pending before the Hon'ble CAT, Guwahati.

5. The promotion of the Inspectors of Central Tax and Customs to the grade of Superintendent are subject to the outcome of various SLPs pending in the Hon'ble Supreme Court on the issue of Seniority in the Grade of Inspectors and any other Orders of Hon'ble CAT/High Courts on the said issue.

6. As per the above promotion the above officers except those who have already been granted financial up gradation involving GP of Rs. 4,800/- under MACP Scheme, shall exercise option for pay fixation under FR 22 (I) (a) (1), within one month from the date of promotion. Option once exercised shall be final.

7. All the above officers should join the post on promotion within 15 (Fifteen) days from the date of issue of this order, failing which, it will be treated that they have not accepted the promotion ab-initio and as a consequence they would be debarred from promotion for a period of one year.
