Sub: ICT in the grade of EA in light of RRs of EA notified on 28-09-2015-reg.

Reference is drawn to Board's F.No.A.32012/18/2019-Ad.III-A dated 22-04-2022 on the above subject wherein the following directions have been given:

at para -3:

"Wherever ICTs were effected in EA cadre, the same not being permissible,

CCAs shall treat such ICTs as deemed loan cases..."

and

at para-4:

"All necessary steps may accordingly be taken in line with the instructions."
