- Further posting orders by the respective Pr. Commissioners / Commissioners within their Commissionerates shall be issued following the provisions of “ Transfer/Placement Guidelines 2023” in respect of Group ‘B’ & ‘C’ Officers of CGST & Customs, Guwahati Zone issued vide GCCO/II/(3)/181/2022-ADMN-O/o CC-CGST-ZONE-GUWAHATI I/1068454/2023 dated 14-03-2023. Any deviation shall be with the prior approval of the Chief Commissioner, CGST & Customs, Guwahati Zone.
- **Officers who are transferred from Customs and posted in CGST formation shall be relieved by 14.06.2024 for completion of procurement of Digital Signature Certificate(DSC) dongle, mapping for assigning the role in GSTN Back Office before they are posted in specific formation. They should furnish all information required for mapping in GSTN BO, DSC Dongle for assigning Role to the CGST Commissionerate System branch where they are posted.**
- Officers who are not having SSO Id should invariably get it done in consultation with System branches.

- All the transferred officers should get themselves de-mapped from the GSTN BO once relieved and take initiative to be mapped in new formations at the earliest.
- All representations received in this regard stand disposed of and no further representation shall be entertained prior to their joining in the new places of posting as mentioned above.
