- The above officers are promoted on in-situ basis at their present place of posting. Their pay fixation shall be subject to their assumption of charge in the promoted grade. They are directed to join the grade immediately. The seniority in the promoted grade shall be in the order indicated above.
- In the event of non-acceptance of promotion, the officer shall be debarred from promotion for one year in terms of DoPT O.M. No. 22034/3/81-Estt.(D) dated 01-10-1981.
- On promotion, the officers may exercise their option for pay fixation under FR-22(I)(a)(i) within one month from the date of assuming charge, as per Ministry of Home Affairs, Dept. of Personnel & A.R. O.M. No. 7/1/80-Estt./Pt. dated 26-09-1981. However, officers who have already received financial upgradation under ACP/MACP to the same level shall not be entitled to pay fixation benefits.

- No arrear shall be allowed arising out of fixation in view of this notional date of promotion till the date on which the officers actually joined in the grade.
- This promotion shall be subject to outcome of any related matter in judicial fora or applicable directions of Board & DoPT, if any.
