The following points may also be noted ;

a. In the event of non-acceptance of the promotion, he/she shall be barred from promotion for the next one year in terms of DOP&T OM No. 22034/3/81-Estt.(D) dated 01-10-1981. On promotion, the above officers may exercise option for fixation of their pay under FR-22(I) (a) (i) within one month from the date of promotion in terms of Deptt. of Personnel & Administration, Reforms O.M. No 7/1/80-Estt./Pt/ dated 24-12-1981. However, officers who have already been granted financial up-gradation under the MACP Scheme in Level 6 (GP 4200 in PB-2) are not entitled for the benefit of pay fixation.

b. Out of the officers as mentioned above, the promotion of the officers on deputation, if any, are to be treated as pro-forma till completion of their deputation tenure and shall be effective from the date he/she returns to the cadre and assumes charge of the promotional post as per Board's letter No. A-11013/18/2024-Ad.IV dated 29-11-2024 (instructions relating to those who are presently on loan posting, if any, as contained in this letter of Board are applicable as per extant provisions).

c. This instant Establishment Order No. 22/ 2026 dated 19-02-2026 issued wherein promotion of Tax Assistants, Gr. 'C' is being granted to the post of Executive Assistant, Gr. 'B' (Non-Gazetted) is subject to outcome of any related matter in judicial fora or applicable directions of Board & DoPT.
