- iii. The consequent local rotation shall be done by the respective Pr. Commissioner/Commissioners within their Commissionerates not later than 7 days from the date of issuance of this order following the provisions of “Transfer/Placement Guidelines 2023” in respect of Group ‘B’ & ‘C’ Officers of CGST & Customs, Guwahati Zone issued vide GCCO/II/(3)/181/2022-ADMN-O/o CC-CGST-ZONE-GUWAHATI I/1068454/2023 dated 14-03-2023 and DoP&T Guidelines issued vide O.M dated 09.10.2024 may also be followed for posting of officers to sensitive posts. Any deviation shall be with the prior approval of the Chief Commissioner, CGST & Customs, Guwahati Zone.
- iv. The Commissioners concerned shall send the compliance report regarding relieving and joining of the above officers to this office **latest by 17.04.2026**.
- v. All representations received till date regarding transfer and posting has been duty considered in the light of the guidelines provided in the transfer policies as well as administrative exigencies in this zone and stand disposed of.
- vi. No further representation shall be entertained prior to their joining at the new places of posting.
- vii. If any officer does not join in his/her new place of posting after relieving from the respective offices within the reasonable period, he/she is liable for disciplinary action.
