**Sub: Notional fixation of promotion in the grade of Superintendent, Gr. 'B', Gazetted. -reg.**

In view of recommendation of Review Committee meeting dated 22-12-2025, **Sh. Chinaopem Khapudang** (category: ST, DOB: 30-Mar-1978) who was regularized in the grade of Superintendent, Gr. 'B' Gazetted notionally w.e.f. 01-March-2022 vide Estt. Order No. 95/2024 dated 21-December-2024, his promotion is hereby rectified and regularized in the grade of Superintendent, Gr. 'B' Gazetted 01-January-2022 with notional effect.

- This granting of promotion is for notional fixation only and does not entitle the concerned officer for grant of any arrears until the date the officer actually initiates workings in the higher grade. The above officer may exercise option for fixation of his pay under FR-22(I) (a)(i) within one month of issuance of this order in terms of DoPT O.M. no 7/1/80-Estt./Pt/ dated 26-09-1981. However, officer who has already been granted financial upgradation under ACP/MACP Scheme in level 8 (GP 4800 in PB-2) are not entitled for benefit of pay fixation.
- His position in the Zonal seniority list of Superintendents shall be rectified as per recommendation of the Review Committee meeting dated 22-12-2025 as applicable and shall reflect in the subsequent publication of Zonal seniority list of Superintendents.
- All promotion and seniority are subject to outcome of related matters in judicial fora and issuance of applicable OMs or Directions issued by DoPT or Board.
