Establishment Order No. 58/2016

Subject: Grant of 3rd Financial Up-gradation under the Modified Assured Career Progression (MACP) Scheme to the grade of Superintendent of Shillong Zone – Order – regarding.

In pursuance of the DOPT's O.M. No. 35034/3/2008-Estt. (D) dated 19th May, 2009, **Shri Manabendra Banik**, Superintendent of Shillong CX Zone is hereby granted **Third Financial Up-gradation** under the Modified Assured Career Progression (MACP) Scheme and is accordingly placed in the Grade Pay as detailed below with effect from the date mentioned against his name.

The above financial up-gradation is subject to the following conditions:-

1. The financial up-gradation will not result in change in designation of the beneficiary, i.e., the financial benefit is granted with the retention of his old designation and the said financial up-gradation shall not confer any privilege related to higher status.
2. The financial up-gradation under the MACP Scheme is purely personal to the incumbent and does not amount to actual functional promotion of the official concerned. It has no relevance to his inter-se seniority position, and as such, there shall be no additional financial up-gradation for the senior officials on the ground that the junior official has got higher pay scale(s) under the Scheme. The concept of "Senior-Junior" is quite alien to the idea behind the MACP Scheme.
3. The above official, while accepting the aforesaid financial benefit, shall be deemed to have given his unqualified acceptance for promotion on occurrence of vacancy subsequently.
4. Benefit of pay fixation available at the time of regular promotion is allowed at the time of financial up-gradation under the Scheme. Therefore, the pay shall be raised by 3% of the total pay in the pay band and the grade pay drawn before the up-gradation. There shall, however, be no further fixation of pay at the time of regular promotion if it is in the same grade pay as granted under MACPS. However, at the time of actual promotion if it happens to be in a post carrying higher grade pay than what is available under MACPS, no pay fixation would be available and only difference of grade pay would be made available.
5. The above official shall exercise option under FR 22 (I) (a) (1) to get his pay fixed in the higher grade pay either from the date of his up-gradation or from the date of his next increment (1st July of the year). Such option (exercisable within one month from the date of receipt of this order) once exercised shall be treated as final. The pay and the date of increment shall be fixed in accordance with clarification no. 2 of Dept. of Expenditure's O.M. No. 1/1/2008-1C dated 13.09.2008.


