Subject: Grant of 1<sup>st</sup> Financial Up-gradation under the Modified Assured Career Progression (MACP) Scheme to Canteen Staff of Shillong Zone – Order – regarding.

n pursuance of the DOPT's O.M. No. 35034/3/2008-Estt. (D) dated 19<sup>th</sup> May, 2009, **Shri Narayan Ch.Patowary**, Salesman-Cum-Coupon Clerk of Shillong CX Zone is hereby granted **First Financial Upgracation** under the Modified Assured Career Progression (MACP) Scheme and is accordingly placed in the Grade Pay as detailed below with effect from the date mentioned against his name.

he above financial up-gradation is subject to the following conditions:-

- 1. 'he financial up-gradation will not result in change in designation of the beneficiary, i.e., the financial benefit is granted with the retention of his old designation and the said financial up-gradation shall not confer any privilege related to higher status.
- 2. he financial up-gradation under the MACP Scheme is purely personal to the incumbent and does not mount to actual functional promotion of the official concerned. It has no relevance to his inter-se senirity position, and as such, there shall be no additional financial up-gradation for the senior officials on the ground that the junior official has got higher pay scale(s) under the Scheme. The conept of "Senior-Junior" is quite alien to the idea behind the MACP Scheme.
- 3. The above official, while accepting the aforesaid financial benefit, shall be deemed to have given his inqualified acceptance for promotion on occurrence of vacancy subsequently.
- 4. lenefit of pay fixation available at the time of regular promotion is allowed at the time of financial up-gadation under the Scheme. Therefore, the pay shall be raised by 3% of the total pay in the pay bandand the grade pay drawn before the up-gradation. There shall, however, be no further fixation of pay it the time of regular promotion if it is in the same grade pay as granted under MACPS. However, at the time of actual promotion if it happens to be in a post carrying higher grade pay than what is available under MACPS, no pay fixation would be available and only difference of grade pay would be made available.
- 5. he above official shall exercise option under FR 22 (I) (a) (1) to get his pay fixed in the higher grace pay either from the date of his up-gradation or from the date of his next increment (1<sup>st</sup> July of the 'ear). Such option (exercisable within one month from the date of receipt of this order) once exercised shall be treated as final. The pay and the date of increment shall be fixed in accordance with clarification no. 2 of Dept. of Expenditure's O.M. No. 1/1/2008-1C dated 13.09.2008.
