Subject: Grant of 3<sup>nd</sup> Financial Up-gradation under the Modified Assured Career Progression (MACP) Scheme to the grade of Superintendent of Shillong Zone – Order – regarding.

In pursuance of the DOPT's O.M. No. 35034/3/2008-Estt. (D) dated 19<sup>th</sup> May, 2009, **Shri Sankar ratim Deb**, Superintendent of Shillong CX Zone is hereby granted **Third Financial Up-gradation** under the lodified Assured Career Progression (MACP) Scheme and is accordingly placed in the Grade Pay as etailed below with effect from the date mentioned against his name.

The above financial up-gradation is subject to the following conditions:-

The financial up-gradation will not result in change in designation of the beneficiaries, i.e., the nancial benefit is granted with the retention of their old designation and the said financial up-gradation hall not confer any privilege related to higher status.

The financial up-gradation under the MACP Scheme is purely personal to the incumbent and does of amount to actual functional promotion of the official concerned. It has no relevance to their inter-se aniority position, and as such, there shall be no additional financial up-gradation for the senior officials on the ground that the junior officials have got higher pay scale(s) under the Scheme. The concept of "Senior-mior" is quite alien to the idea behind the MACP Scheme.

The above official, while accepting the aforesaid financial benefit, shall be deemed to have given s unqualified acceptance for promotion on occurrence of vacancy subsequently.

Benefit of pay fixation available at the time of regular promotion is allowed at the time of financial o-gradation under the Scheme. There shall, however, be no further fixation of pay at the time of regular omotion if it is in the same grade pay as granted under MACP Scheme.

The above official shall exercise option under FR 22 (I) (a) (1) to get his pay fixed in the higher ade pay either from the date of his up-gradation or from the date of his next increment. Such option xercisable within one month from the date of receipt of this order) once exercised shall be treated in final.
