In pursuance of the DoP&T's O.M. No. 35034/3/2008 -Estt.(D) dated the 19th May, 2009, tfollowing Inspectors of Shillong CX Zone are hereby granted First Financial Up-gradation ter the Modified Assured Career Progression Scheme and are accordingly placed in Level – 8 of the Pay Matrix corresponding to the Grade Pay of ₹ 4,800/- in PB-2 (pre-revised) with effect from tlates mentioned against each.

The Financial Up-gradations granted to the above officials are subject to, inter-alia, the fwing conditions:-

The financial up-gradations will not result in change in the designation of the beneficiaries ithe financial benefit is granted with the retention of their old designation and the said facial up-gradation shall not confer any privilege related to higher status.

The financial up-gradation under the MACP Scheme shall be purely personal to the imbents (officials) and shall not amount to actual functional promotion of the officials cerned. And it shall have no relevance to their inter-se seniority position, and as such, there s be no additional financial up-gradation for the senior officials on the ground that the junior cial has got higher pay scale(s) under the MACP Scheme. The concept of "Senior-Junior" is c alien to the idea behind the MACP Scheme.

Grant of higher pay-scale(s) under the MACP Scheme shall be conditional to the fact that tibove officials, while accepting the aforesaid financial benefit, shall be deemed to have given ti unqualified acceptance for promotion on occurrence of vacancy subsequently.

Benefit of pay fixation available at the time of regular promotion shall also be allowed at time of financial up-gradation under the Scheme. There shall, however, be no further fixation ay at the time of regular promotion if it is in the same grade pay as granted under MACPS.

Further, while implementing the MACP Scheme, the differences in pay scales on account cant of financial up-gradation under the old ACP Scheme (of August 1999) and under the CP Scheme within the same cadre shall not be construed as an anomaly.

The above officials shall exercise option under FR 22 (I) (a) (1) to get their pay fixed in the higher grade pay either from the date of their up-gradation or from the date of their next increment. Such option (exercisable within one month from the date of receipt of this order) once exercised shall be treated as final.
